Conor Peters Statement of Faith

I believe in the Triune God, the creator, redeemer, and sustainer, who is always present, and whose love is never ceasing. It is because of the love of God, made evident through Christ Jesus, that I have received new life.

The Son of God, in communion with God the Father and God the Holy Spirit, became the Word made flesh in Jesus Christ from the womb of the virgin Mary. The Son of God, fully human and fully divine, lived a sinless life, teaching God's goodness, God's love, and the Kingdom of Heaven. In Christ's crucifixion and resurrection, God reveals God's grace and love that sets us free to fully live into God's call for our lives, to bring glory to God in all we do, to interact with culture and respond to world around us, and to make disciples.

This is only accomplished through the presence and guidance of the Holy Spirit. The Holy Spirit is God beyond us and within us, who guides, convicts, speaks through, and speaks to us in order for humanity to grow into who God has called us to be, and to spread the good news of Jesus Christ.

Christ's Church exists in many different forms all around the world. Where two or more are gathered in Christ's name, so is the Church. To be a part of the Church is to be part of a community of believers of Jesus Christ whose mission is to encourage each other, hold each other accountable to God's call on our lives, and share God's Kingdom with the world. As followers of Jesus, we are called to be an active participant in Christ's Church with our spiritual and material gifts. Through the presence of the Holy Spirit in Baptism and Holy Communion, our participation in these sacraments sustains us in upholding Christ's call for our lives and draws us into deeper relationship with Christ.

In the sacrament of Baptism, one makes an outward declaration of an inward transformation through the power of the Holy Spirit. While we are not saved through Baptism, Baptism is a response to the work of the Holy Spirit in our lives and testifies of the grace that has been received through Jesus.

In the sacrament of Holy Communion, we come to God and confess our sins, receive the grace of Jesus, and grow into deeper relationship with God through the presence and power of the Holy Spirit.

The Holy Scriptures are the inspired Word of God that reveal to us the story of God's relationship with God's people. In the Holy Scriptures the character of God is revealed through God's relationship with Israel and who God is in Jesus Christ. The Holy Scriptures are more fully understood through the illumination of the Holy Spirit.

Through the power of God the Father, the atoning death and resurrection of Christ, and the ever-present guidance of the Holy Spirit, we live into Christ's call for our lives by engaging in the world around us and sharing the good news of Jesus.

Karla Dias Statement of Faith

I believe in the triune eternal God who is holy, sovereign, unlimited, omnipotent, omniscient, and omnipresent. I believe that God is love, and that God created the world and created us in God's image. God's providential care for us means that God is also deeply interested in humanity and that God has a plan for God's creation and creatures. However, since the beginning of our creation, people turned away from God and lived a life of sin. Even when human beings wanted to do the right thing, they played at being God, becoming idolaters, and sinned by doing things like lying, stealing, coveting, hating, and hurting others. But God, with infinite wisdom, found a way to fix this by sending God's own Son to the world, Jesus Christ, to save and redeem us.

I believe that Jesus, came from heaven to earth as both God and human, teaching us how to love and serve God and neighbor. Jesus made the ultimate sacrifice for us by dying for our sins on the cross, thus atoning for our sins. He conquered death through his resurrection on the third day, providing us with eternal life with God. We are justified and made right with God through our faith in Jesus.

When Jesus ascended into heaven, he did not leave us alone. Christ sent us the Holy Spirit, the third person of the Trinity, to comfort us, to guide us, and to manifest the fruits of the spirit in and through us. The Holy Spirit is everywhere, and is constantly at work. As Christians, we come to faith through the power of the Holy Spirit, and the Spirit gives us a taste of the Kingdom of God here on earth.

The Bible, God's Word, is inspired by God, and was recorded by humans at different points of time in history. The Bible is our authoritative guide, and it speaks to us, to how we are to live and share our faith. It is the awesome story of God's love for God's people, and Jesus is the perfect expression of God's love. The Bible helps us to know and to love God, and it teaches and encourages the church to serve God as God wants to.

The church is the body of Christ in the world. It is people of faith who gather to worship and serve the Savior and the Lord of our lives, not a building of four walls.

In our worship life together, we celebrate two sacraments because Christ commanded us to. With the presence of the Holy Spirit, we baptize in the name of the triune God and welcome individuals into God's family. The sacrament of baptism is celebrated in community, during which the church joyfully promises to nurture the baptized in their faith.

The Lord's Supper is where we remember what Jesus did for us, giving his body and blood for us for the forgiveness of our sins. We partake of the bread and cup as spiritual food that nourishes us so that we may serve Jesus with humility and love.

These two sacraments are central to our worship, faith, and life together as the church. They remind of God's grace and goodness in our lives.

As a church, our mission is to be at work in the world. We are Christians on the go!

We are to share the love of God found in and through Jesus, we are to do good, to be helpers, to attend to the needs of our neighbors near and far, to welcome others and express hospitality, to seek justice, to work for peace, and share the joy of our faith. We are to live a life of thankful, humble service to our Lord and Savior, Jesus Christ.

As a pastor, I believe I am called to love God with all I have got and to serve whoever, whenever, and wherever God places me. I promise to always seek the help of God in my ministry through prayer, and I will strive to serve God's people with my whole heart, energy, and good humor, being open to ministry everywhere.

Chapel by the Sea Sale of Property MOTION:

To approve the engagement of Investment Properties Corporation to market the properties on Fort Myers Beach, described as 100 Chapel Street, SEAGRAPE SUBD.PB 4 PG 17 BLK.B LTS 1-8 + BLK D LTS 16 -18 + OR 221 PG 436 (STRAP: 19-46-24-W3-0120B.0010) and 2471 Estero Boulevard SEAGRAPE SUBD BLK D PB 4 PG 17 LT 19 LEASEHOLD INT (STRAP: 19-46-24-W3-0120D.0190) at a combined properties list price of \$8.5 million with a minimum agreed upon sales price at the appraisal value received at time of listing the property.

Background: The Finance Committee considered proposals from two commercial real estate brokerage firms; one with a national footprint, a partner arrangement with PCUSA and a current church property listing on Fort Myers Beach. The other, a local firm, founded in 1976, the oldest commercial brokerage firm in Naples, with significant industry and municipality connections. The latter firm, Investment Properties Corporation, was interviewed by the committee and is being unanimously recommended for the presbytery's action.

For Information Only:

Loan Request from First Presbyterian Sarasota to Presbyterian Investment and Loan Program in the amount of \$250,000 to fund critical roof repairs following damage sustained during Hurricane Milton. Request was approved unanimously with prayers for a full recovery from storm damage. For readers unfamiliar with the borrowing program: <https://pilp.pcusa.org/borrow/>

Audit Services: Dees and Dees CPA completed the review of the 2024 financials. The Finance Committee received a clean opinion that the financial statements reflect fairly the financial position of the presbytery and accepted the report. Anyone wishing to receive a copy of the report should contact Treasurer Charmaine. Page 3 for opinion letter. It is noted that Dees and Dees CPA has made the decision to stop providing audit/review services, so the Finance Committee will be seeking a new audit/review firm. We invite any recommendations from churches who have experience working with a firm that has offered good service at a reasonable price.

Blessing Grant Distribution Amount Declared: \$42,550. As per the calculation in the Presbytery's Financial Policies, the spending formula section, the average account value as reported on a quarterly account statement for the previous 12 quarters, or as many quarters as possible, shall be multiplied by 4%. Application information is available at: <https://peaceriverpresbytery.org/grants-loans/>

Other Property Matters Under Consideration: two other property matters are on the radar screen. The first is a request being considered by Holy Trinity for an easement to be granted to the developer/owner of the adjacent property wanting to create an emergency access for a planned apartment complex. The reader is reminded of the Standing Rules that provide guidance on property matters: The Finance Committee is charged “to consider and decide requests to sell real property not used for worship held in trust by congregations of the Presbytery under the provisions of the Book of Order, subject to any exceptions enacted by the Presbytery. All such actions shall be reported to the Presbytery at the next Stated Meeting.”

Additionally, “The Property Lease Commission shall review and approve or deny requests to lease real property used for worship held in trust by congregations of the Presbytery under the provisions of the Book of Order. All such actions shall be reported to the Presbytery at the next Stated Meeting. The Property Lease Commission shall consider and decide all requests to lease for 5 or more years real property not used for worship held in trust by congregations of the Presbytery under the provisions of the Book of Order. All such actions shall be reported to the Presbytery at the next Stated Meeting.

The second property matter relates to the equity sharing arrangement that was part of a new church development in Lakewood Ranch 20 years ago. With the pastor retiring, the private property is planned to be sold and the presbytery will close out the equity sharing transaction.

Webinar Workshop Offering: Hearing the breadth of insurance issues that churches are facing it was decided to host a webinar on the topic of insurance coverage, options, and other considerations. On June 3 at 10:00 we will host an Insurance Wellness Webinar with the presbytery’s insurance agent, Earl Burkett. He will offer a 30 minute rapid fire review of the insurance coverages and considerations that churches should have on their radar screen, followed by 30 minutes of questions. Be sure to inform your church leaders in the areas of finance and property. Watch for registration information in the newsletter from the presbytery.

Review of January, February and March 2025 Financials: At each meeting the Finance Committee reviews the prior month financials, the church giving report and the funds/accounts summary.

The information is also shared with the Steering Committee members. Summary comments and an overview report regarding the March financials appear on pages 4-7. Of interest is the giving report through March 2025 on pages 8-9. We celebrate every gift of money and support for the work of the presbytery. Detailed March 2025 financial reports appear in the APPENDIX.

Presbytery Women Review of Financials: The annual financial review with Presbyterian Women is scheduled to happen in May.

Election of Vice Moderator of Finance Committee: Roger Schultz was elected to the position of vice-moderator as it is anticipated that Mary Lynn Myers will pass the leadership baton at the end of the year. The committee is grateful for all leaders --- past, present and future.

Headline: With the first quarter coming to a close, and more black ink on the dashboard, there is reason for cautious optimism. Of greatest optimism is that two more church pledges have been received, exceeding last year's pledges by \$26K or 10%.

Mission Stream: The reader is reminded that some of the mission stream money that would have passed through the Presbytery books in the past is flowing directly to Mision Peniel. That is being calculated as part of the Presbytery's \$150K commitment for 2025. The MP lease payment and Board of Pension dues, reported on the statement, are also calculated as part of the \$150K commitment for 2025. In the OTHER income section of the report you will notice that hurricane recovery grants were awarded to five churches.

PRP Ministry Operations: March was a solid month for revenue and YTD revenue is running ahead of 2024. While the NET before transfers show a positive, the detailed report shows that two months of accounting services have not been invoiced. Factoring in that cost, the operations for March would be a breakeven and the YTD NET before transfers would be at a \$16K deficit, of which \$12K is attributed to the departure of the office administrator. COM granted \$1K to a church to supplement a transitional expense. A transfer was made from the investment account to cover the distribution of the hurricane recovery grants, and thus showing a surplus balance. Expense control continues to be the order of the day for the operations.

Per Capita Stream: Revenue continues to run ahead of 2024. The expenses are calculated at 1/12 of the budget per capita commitment each month.

Summary of Funda and Accounts Report: The partial draw (\$46,700) to cover the hurricane recovery grants is noted. At quarter end, the investments are marked-to-market, showing a gain in the investment portfolio since year end.

Giving Report: Here's the reason for optimism. This year 18 churches have offered their pledges in the amount of \$301K, \$26K more than total pledges in 2024. Last year at the end of the first quarter there were ten churches which had not shared their resources with the Presbytery. This year, that stands at eight churches. Additionally, pastor pledges have been noted for the first time. Your generosity is a blessing. If the reader is looking at your own church's record, keep in mind that the presbytery operates with a 5-day cut-off prior to the end of the month. 2024 *member* numbers have also been added to the report; see left-hand columns for three-year trend information.
